**RESOLUTION OF PENN TOWNSHIP, ST. JOSEPH COUNTY, INDIANA  
AMENDING THE EXISTING SALARY RESOLUTION 2020-08 AND AWARDING  
ADDITIONAL COMPENSATION FOR TOWNSHIP EMPLOYEES**

**WHEREAS**, the Board of Penn Civil Township, St. Joseph County, Indiana met at a duly called and authorized meeting of the Board of Penn Township on the date set forth below, such meeting having been called pursuant to a published notice posted at the Penn Township Trustee's Office more than forty-eight (48) hours in advance of the meeting and which notice stated the time, place and purpose of the meeting and which was received by all Penn Township Board Members; and

**WHEREAS**, the following resolutions were made, seconded and adopted by those present at the meeting; and

**WHEREAS**, the pursuant to Indiana Code 36-6-6-10, the Board of Penn Township is authorized to change the salary of any employee, if the necessary funds and appropriations are available; and

**WHEREAS**, in order to reward Penn Township employees for their dedicated service throughout the continuing pandemic, the Board of Penn Township desires to compensate each of them based upon their full-time or part-time status in 2021; and

**WHEREAS**, the necessary funds are available to compensate them from the Rainy Day Fund, #0061 Line #1A, 100% without additional appropriations; and

**WHEREAS**, it is necessary to amend the existing salary Resolution #2020-08 as written or amended;

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Penn Township hereby amends the existing salary resolution, Resolution #2020-08, to award additional compensation to its employees based on their full-time or part-time status in 2021, in the following amounts:


Full-Time Employees:	\$1,500.00
Part-Time Employees:	\$ 250.00
Fire Chief:	\$1,500.00
Operations Chief:	\$1,500.00

**BE IT FURTHER RESOLVED** that effective December 21, 2021, the Board of Penn Township authorizes the Penn Township Trustee to pay said employees the compensation above from Fund #0061 Line #1A, 100%.


**BE IT FURTHER RESOLVED** that all other sections of existing salary Resolution #2020-08 remain in effect as written or amended.
